On Sunday, 06/14/20, at approximately 1917 hours, Corporal K. Sherrill (873), Deputy M. Spencer (1277) and Deputy T. Chaney (4685) responded to 4029 Gardenwood Circle, Grant, Brevard County, Florida, in reference to a suicide threat.

Mr. Jay Fondren (Complainant), contacted the Brevard County Sheriff's Office regarding what he believed to be concerning comments posted by Kathleen Edwards (Involved) on "Formation 22," which is a private Facebook group for victims suffering from Post-Traumatic Stress Disorder (PTSD). Mr. Fondren is the Texas Outreach Manager for the PTSD Foundation of America, he was calling from Houston, Texas. Mr. Fondren advised the female, later identified as Kathleen Edwards, posted on Facebook (Formation 22 – Group) that she was thinking of committing suicide. Mr. Fondren indicated that several members of the "Formation 22" group had expressed concern for Ms. Edwards. After these concerns were expressed, the Executive Director for the PTSD Foundation of American reached out to Mr. Fondren to gather additional information about Ms. Edwards, so the appropriate law enforcement jurisdiction could make contact and evaluate her mental health. Ms. Edwards is the wife of Gregory Edwards and uses the screen name, "Holly K. Edwards."

Corporal Sherrill, Deputy Spencer and Deputy Chaney arrived on scene and attempted to make contact with Ms. Edwards, there was no answer at her front door. Two cars were in the driveway, both of which were not registered to Ms. Edwards. Corporal Sherrill made contact with Ms. Edwards' neighbor, at shared concerns regarding the mental health and well-being of Ms. Edwards. Corporal Sherrill telephoned me and briefed me on the status of the case and the concerns expressed by Lieutenant R. Vitaliano later responded to and obtained an audio recorded statement from (see supplemental report by Lt. Vitaliano).

On 06/14/20, at approximately 2018 hours, I arrived on scene and made contact with the above-listed Deputies. Corporal Sherrill obtained via text, a screen capture of the Facebook post made by Ms. Edwards from Mr. Fondren. I reviewed the screen capture of the Facebook post and immediately shared my concerns for Ms. Edwards' mental health and well-being with Major Carlos Reyes. Next, I called Ms. Edwards and we spoke for several minutes by phone. I advised her of the purpose for the Brevard County Sheriff's Office response to her residence and asked that she meet with me outside so I could check her well-being. Ms. Edwards stated she was not comfortable meeting with me in person, but stated that she was fine and had no suicidal thoughts. A short time later, a female exited the residence and stated she was Ms. Edwards' sister (unknown name). I explained to the sister that I needed to physically see Ms. Edwards to confirm that she had not caused any physical harm to herself.

Due to the significance of this call, Sheriff Wayne Ivey responded to the scene.

Sheriff Ivey, Major Reyes and I made contact with Ms. Edwards in the driveway of her residence. Ms. Edwards was accompanied by a small group of family and friends. Major Reyes and I stood by while Sheriff Ivey spoke with Ms. Edwards. During that conversation, Sheriff Ivey asked Ms. Edwards to make a promise to him that she had not and would not cause any harm to herself. At the conclusion of the conversation with Sheriff Ivey, and based upon my personal evaluation through discussion and observation Ms. Edwards did not meet the criteria for an involuntary mental health

she felt obligated to do what was being asked because the groups organizing the local protests were contributing mone to make signs on her behalf. Mrs. Edwards did not always want to participate in these events but it was made clear to he that she owed them because of the money they have spent on her behalf. Mrs. Edwards told that the individuals talking to her wanted her to run for Brevard County Sheriff. Mrs. Edwards also stated these unknown individuals wanted Mrs. Edwards to announce her running for Brevard County Sheriff in Sheriff Wayne Ivey's front yard. When Mrs. Edwards told this information, Mrs. Edwards stated it was "fucked up", to which agreed. believes Mrs. Edwards knows right from wrong but is being pressured and convinced by these unknown people to do what they want.	iei t
stated that Mrs. Edwards appeared to struggle between dealing with these unknown people pressuring her and moving on with her life. described these unknown individuals as "brainwashing" Mrs. Edwards into doing what they want and their way of thinking.	
Although Mrs. Edwards confided many things with she never disclosed any names of the individuals or groups that have been in contact with her. are very concerned if this behavior continues it could be detrimental to Mrs. Edwards' mental health.
